Applications - Called for.

- (2) The gazette of India 82 dated March 1, 2019 and AICTE CAS regulation F.No.61-1/RFID/7TH CPC/2016-17 dated March 1, 2019.

CAREER ADVANCEMENT SCHEME (CAS)

Applications are invited from the eligible faculty members of the Pondicherry Engineering College for promotion under the Career Advancement Scheme (CAS). Those who are eligible / qualified on or before the last date for submission of application viz., 23.07.2021 may apply. The faculty members who have already applied for the promotion under CAS based on the circular dated 28-02-2020, need not apply again, except if they qualify for new higher post / stage.

S.No.	DETAILS OF MOVEMENT
1.	Assistant Professor Stage 1 (AGP 6000) to Assistant Professor Stage 2 (AGP 7000)
2.	Assistant Professor Stage 2 (AGP 7000) to Assistant Professor Stage 3 (AGP 8000)
3.	Assistant Professor Stage 3 (AGP 8000) to Associate Professor Stage 4 (AGP 9000)
4.	Associate Professor Stage 4 (AGP 9000) to Professor Stage 5 (AGP 10000)
5.	Professor Stage 5 (AGP 10000) to Professor Stage 6 (AGP 12000)

Applications should be submitted with the details given below (as per AICTE Norms):

- (a) Faculty members who qualify for any of the stages on or before 7-11-2015 are exempted from Academic Performance Indicator (API) and the qualifications required for the movement from one stage to another stage are as per AICTE norms of 6th CPC.
- (b) Faculty members who qualify for any of the stages on or after 8-11-2015 but on or before 28-02-2019 will be assessed with Academic Performance Indicator (API) and the qualifications required for the movement from one stage to another stage are as per AICTE norms of 6th CPC (F.No. 37-3/Legal/AICTE/2012 dated November 8 2012).

- (c) Faculty members who are eligible for promotions after the date of publication of the gazette F.No. 61-1/RFID/7th CPC/2016-17 dated March 1, 2019 shall have to meet the necessary conditions such as additional qualification, undergoing industrial training, pedagogical training, faculty induction program, publishing research papers etc. However, these requirements shall be permitted to be fulfilled till 31st July, 2022 so as to enable faculty members in equipping them for requisite mandatory requirements of this gazette to avail the benefit of promotion retrospectively from the date of eligibility.
- (d) For incumbent faculty members, the date of eligibility up to 31st July, 2022 shall be allowed to be according to the 6th CPC Gazette notification published on 8th November, 2012. All the benefit of promotion to such candidates be permitted retrospectively on the date when he/she become eligible as per 7th CPC Gazette notification.
- (e) Eligible staff members are requested to submit "separate application" for the upward movement of "each stage".
The notification, important instruction, eligibility conditions for staff members available on the website: <https://pec.edu>. The staff members are requested to download and read the entire document and AICTE notifications before apply for the promotion under CAS.

The last date for submission for the application is 23-07-2021. Template of the application can be down loaded from the web site and submit the same along with supporting documents to the under signed on or before 23-07-2021.
